NATIVE LUMBER. Native lumber is wood processed in Massachusetts by a mill registered in accordance with the regulations (780 CMR) of the BBRS. Such wood is ungraded but is stamped or certified in accordance with Chapter 23 of the *International Building Code 2009* with the Massachusetts Amendments (780 CMR 23.00). Native lumber shall be restricted to use in one-and two-story dwellings, barns, sheds, agricultural and accessory buildings and structures and other uses as permitted by Chapter 23 of the *International Building Code 2009* with the Massachusetts Amendments (780 CMR 23.00).

NATIVE LUMBER PRODUCERS. Persons or corporations in the business of milling wood into native lumber within Massachusetts.

As best I can tell for the purpose of using lumber cut on my land I can simply become a registered "mill" for this purpose by application for identifying numbers. For the purpose of Native Lumber the rules seem to to provide for identification of the source of the lumber and have no special other requirements. I have initiated the application process and we will see where it goes. I intend to have the boards cut at Crossroads Farm Sawmill in Uxbridge.

I have tried to initiate the registration on the web site he suggested. I filled in the forms to become an IPS user and have been waiting for the response which has not come.

gives a 404 not found error.

I called Robert several times. One time last week we spoke briefly and he said he would call back. Other times messages I left have not gotten a return phone call. I left an additional message a few minutes ago.

I am happy to register and pay the appropriate fee, please just enable that process so I can do it successfully.

I am a little guy trying to do things right. You are a big state agency. Please find a way to make it possible for the little guy to follow the rules and still be able to do what he is allowed to do under the law.

I have never got any email. I looked in spam folders and other places.

Giuliano change my email address to one that does not need to forward (dragonnorth@gmail.com) and I was able to get the confirmation email and could log in.

Perhaps this email failure was the source of the problem.

I was able to complete the registration. The fee payment would not accept any of several credit cards. Is is possible that it only accepts MasterCard (I don't happen to have one I tried Visa and AMEX cards). I was able to pay with a bank account debit. The fee charged was \$100. This is inconsistent with what is stated elsewhere on the web sites (they say \$50).

The fee paying process used the initial email mnewman@dragonnorth.com. I did not get any confirmation emails.

The application process asked several questions about my corporate entity. Since I am applying as a person rather than a corporation the answers I gave did not quite fit the questions (my state of incorporation for example I said MA which is both where I was born and where I live).

Hopefully the rest of this process will go smoothly.
